We are very happy with the continuing success of our First Tuesday programs and our Thursday Evening Genealogy Club workshops and speakers (monthly on the second Thursday, and sporadically on additional Thursday evenings). We have been pleased to introduce so many of West Virginia's history professors, scholars and writers to a broader audience, and have given speakers an opportunity to talk about personal research projects and favorite topics not often presented in the venues normally open to them. Audiences have appreciated meeting the speakers, have had questions answered, and have provided additional information from their own experiences and perspectives. Most authors have had copies of their books available, and/or have gladly signed books. Date Terminology: Ult., Inst., and Prox.

Terminology quite common for generations can fall out of favor over time. Many in English are Latin terms that served as shorthand for longer English phrases or word combinations, but are no longer used in modern language outside of legal documents. Latin itself is seldom taught in public schools, so few people today can puzzle out the meaning of a Latin term or of an English word by recognizing its Latin root. A method of briefly writing the month of occurrence of an action or event in the same year as the composition is being written is to use one of the following three Latin words or their abbreviations:

ultimo: in the last month: ult. instant: of, or occurring in, the

present month: inst. proximo: in the next or following month: prox.

Instant is used either in full or in abbreviation, but *ultimo* and *proximo*

seem to have been used much more often in abbreviation than in full spelling. Because they are non-English words, you may see them in print in italics.

When trying to date a letter, newspaper article or other composition using one of these terms, one must consider several factors to determine the name of the month to which the word refers. In a letter, go by the date the letter was written, particularly if the letter is dated by the writer. If the letter you are reading was dated June 25 and the author penned "in reply to your letter of the 15th *inst.*," the reference was to a letter written or received on June 15. If the letter was not dated, or has a date supplied by someone else later, look for internal *Continued on the next page*

June 5 Library Program to Look at Old Malden

On June 5, 2012, Larry L. Rowe will present "Malden and the Salt Industry" at the Tuesday evening lecture in the Archives and History Library. The program will begin at 6:00 p.m. and is free and open to the public.

Larry Rowe will discuss his research and analysis of the history of Old Malden and how its race culture is unique because of the town's heritage as an early American industrial center in a mountain frontier culture where enslaved persons lived and worked alongside white workers. This history centers on the boyhood times of Booker T. Washington, whose life in Malden set his belief in hard work, family life, and middle class values and affirmed his trust in the best ideals of America.

Rowe is a graduate of West Virginia University, where he was Phi

clues and combine them with dates of events you already know. "In preparation for your birthday on the 10th *prox.*," means the letter was written in April, if you know that the person being addressed was born in May. "Regarding your address to the historical society on the 4th *ult.*" means the letter was written in July, if you know the letter recipient gave a speech to the society on June 4 of that year.

In a newspaper, figure from the publication date of the newspaper if the article was printed for the first time by that newspaper and first printed in that issue. If this is the case, determine the month being referred to by the date of the newspaper. "During his trial for assault on the 10th instant, the defendant confessed under oath." as a statement appearing in the newspaper on March 30, dates the event as March 10 of that same year. Note that often newspapers directly lifted articles in full or in part from other newspapers, usually citing the original source, but not always providing the date of the original publication. If you do not know the date of the original writing and publication, determining the month of reference is trickier. You may have to search the original publication for the article, to confirm or amend the date of action. If the above example was cited with the name of a Pittsburgh newspaper as its source and reprinted in a Wheeling newspaper on March 8, obviously the reference to the "10th instant" cannot mean March10. Most likely it means February 10, but you would verify it by checking the February issue of the Pittsburgh paper.

If you are interested in semantics, head for your favorite "big" dictionary, like the 2,662-page Webster's Third New International Dictionary, unabridged, in the Archives and History Library. Study the various meanings of words more

His passion for Malden's history began when he purchased the home of Minnie Wayne Cooper, an African American leader and educator. and heard stories of her childhood when "Uncle Booker" would visit in Malden with his sister, Amanda Johnson, her mother's best friend. He considers the love of Malden and West Virginia as a passion and a moral duty.

The Kanawha Valley and Fort Lee Take Center Stage at June 14 Library Program

On June 14, 2012, Gilbert Casto will present "History of the Kanawha Valley and Fort Lee" at the Thursday evening lecture in the Archives and History Library in the Culture Center in Charleston. The program will begin at 6:00 p.m. and is free and open to the public.

Casto will discuss the settlement of the Kanawha Valley in the 18th century, including who came to the valley and why they came. In addition, he will talk about the different forts in the valley and some of the resources useful to research into the time period. Casto also plans to show the dress, weapons, and accouterments the settlers carried. An open discussion during the presentation is encouraged.

A native West Virginian, Casto's family has lived in the area since 1800. He is a graduate of West Virginia State University and is retired from Republic Container Company of Nitro. His hobbies include providing interpretation of the 18th-century Kanawha Valley to school and other groups and giving demonstrations at Fort Randolph in

common to us-ultimate, proximate and instant-for some insight into the development of meanings and usage of the Latin roots that may help you remember the meanings of ultimo, instant and proximo in dates. Briefly, ultimate has meanings of "last, final, last in a progression." With that in mind, think of ultimo as indicating the last final, or complete, month to the current one, last in the progression of past months. Proximate has meanings of "very near" and "adjoining." Proximo indicates the adjoining month, the month nearly here. Instant, while also an English word very familiar to us, is less clear in its connection to use in dates in the bulk of listings. but the closest definitions near the ends of the listings are ones of "immediateness," or "present, current," as well as "point in time" with this implied. Instant is then the immediate, present or current

West Virginia and the Tri-State Area have lost a lovely researcher and genealogist. Sheri K. Pettit was a member of the KYOWVA Genealogical Society where she served in many offices including president. She was one of the energies behind the Mining Your History Foundation, a friends and advocacy group for the West Virginia State Archives. She was author of over eight titles and worked for many years at the Boyd County Public Library Genealogy Collection in Ashland, Kentucky. Sheri enjoyed digging into difficult genealogy problems and assisting researchers in southwestern West Virginia. An avid Civil War reenactor, her hoops never got in the way. She was one of the supporters of the Barboursville and Guyandotte Civil War Days. Sheri K. Pettit died in Florida after an extended illness. She is survived by her husband Rick.

In Memoriam Jerry Grady

West Virginia Archives and History lost one of its volunteers when Jerry Grady passed away on May 1 after a long illness. He is survived by his wife Pamela, daughters Jessica and Melissa, and brother Gary, to whom we send our condolences.

Before retiring in 2010, Jerry worked in his native Jackson County as a WVU Extention agent for 4-H, adult education teacher and coordinator, school counseler, and West Virginia Studies teacher. In 2010, he received an honorary Golden Horseshoe.

Jerry became a volunteer for Archives and History in November 2010 when he began scanning militia letters for one of our sesquicentennial projects. He completed work on this project in May 2011. While Jerry was not the only person who worked on that project, he was responsible for digitizing the bulk of the more than 4,100 pages involved. His dedication to the project led to an article in the Charleston Gazette-Mail. (He also was the subject of an article that appeared in the March 2011 issue of Archives and History News, available online.)

Jerry remained a visitor after this project was completed, working on his own research on his family and the Jackson County 4-H and attending our evening programs. As the months passed and illness took its toll, Jerry came less frequently. Yet, even then, whenever he came he made the day a little brighter.

Comments on his Facebook page reveal that Jerry had a profound impact on many people with whom he interacted as a social studies teacher, through 4-H, and elsewhere. So, too, on us. We will miss you, Jerry.

Suncrest Middle School is 2012 West Virginia History Bowl Champion

Suncrest Middle School (Monongalia County) won the 3rd annual West Virginia State History Bowl on April 24, 2012, besting 15 other regional team winners and runners up with their knowledge of West Virginia facts in a day-long competition in the Culture Center in Charleston. As first place winners each Suncrest team member received \$500. Horace Mann Middle School (Kanawha County) placed second with each member receiving \$250, followed by Shady Spring Middle School Team One (Raleigh County) in third place with each member receiving \$125, and Cameron High School Team One (Marshall County) in fourth with each member receiving \$50. The doubleelimination tournament sponsored by the West Virginia Division of Culture and History for eighth graders included lightning rounds and team rounds featuring questions about state and county history, culture, geography, biography, heritage and tourism prepared by the staff of the Division's Archives and History Section. Suncrest Middle School's championship team included Roark Sizemore, Sadaf Sarwari, Tee Tanner, and Tournament MVP. Matteo Peries. An all-tournament team was also named, formed of the individual students who answered the most questions correctly for their teams over the course of the tournament.

Newspapers Currently Received in the Archives and History Library

The West Virginia Archives and History Library subscribes to all West Virginia newspapers, from the smallest weekly paper to the largest daily. We also spend an additional \$15,000 to \$20,000 per year for subscriptions to ten of the state's daily papers on commercial microfilm. The remaining newspapers are microfilmed in-house from our own paper copies. The newspaper subscriptions are a major expense for Archives and History, so any donations toward subscriptions would be deeply appreciated. If you would like to subscribe to your local or hometown newspaper on behalf of the State Archives, be it for a few months or a year, please contact Joe Geiger, director, (304) 558-0230, joe.n.geiger@wv.gov. Donations will be gladly accepted from individuals or organizations, and may be made in memory or in honor of someone. Donations will be acknowledged by letter and by publication in West Virginia Archives and History News.

We have included a chart entitled "Newspapers Currently Received in the West Virginia Archives and History Library" in this issue for your reference. When we provided

this list in the past, we identified publication type of each paper as "daily" or "weekly," but this list provides actual frequency of publication instead. Newspapers classified as daily may only print five times per week, while papers classified as weekly may actually publish three times a week. More newspapers now have combined issues for weekends or holidays, and we have indicated those where known, most notably the Charleston newspapers which combine on the weekends and holidays but maintain separate editorial pages in the combined publication. The *Glenville* Democrat and the Glenville Pathfinder (self-identified as Republican) appear to be the same content only with different mastheads, and publish on the same day with the same staff.
